Helping Students See A New World



I served as the International Student Representative for GIS from Oct 2017-Oct 2018 and I'd love to share how I was involved. First, it was great to getting to know the GIS grand chapter staff better. These women work very hard to make GIS run smoothly and you may not even notice it as a member or as an alumnus. I also got to know the GIS Board of Trustees and Executive Council. These groups are made up of leaders from well-known insurance companies, consulting companies, insurance education, and other organizations. We met two times last year to discuss new initiatives, marketing, funding, regional conferences, etc. As ISR I was involved with helping wherever grand chapter needed me. Before my term ended, I got to assist grand chapter at the International Conference in Chicago. I was so happy to see other alumnus there as well! Throughout my time as ISR, I gained a great appreciation for all of the work that is done behind the scenes to give GIS such a great reputation in the insurance industry. Enterprise Risk Management (ERM) Analyst for American Equity Investment Life Insurance Company. In this role, I assist with risk governance, which includes managing the risk registry. The registry groups similar risks into categories named 'risk pillars', lists strategies for mitigating these risks, and includes ratings for likelihood and impact. From these ratings can produce reports/dashboards for management that describe the status of the risks in each risk pillar. I have also been learning about best practices for Model Risk Management, including validating that our models are functioning in the way they were designed and being interpreted correctly. In the next few months I will be assisting with stress testing under various potential economic scenarios. Although I'm not working in a traditional entrylevel actuarial role, I still have the opportunity to continue sitting for actuarial exams. It's been eye-opening to see rating agencies adapt their standards for evaluating a company's ERM even within the first 3 months I've been on the job – things change very quickly and there is always something new to learn every day.
